

Cash Converters Access the Cash

Terms and conditions of entry

- Entries for the Cash Converter “Access the Cash” Game show closed on 9 February 2021.
- Successful applicants will be contacted by the Production Company: *Red Pepper Pictures (PTY Ltd)*.
- Candidates must be available for a full day TV recording in a TV studio, exclusively to the production on the agreed date.
- On the agreed date, candidates will be required to avail themselves at Red Pepper Pictures studio in Linden, Johannesburg, at a pre-arranged time and date.
- Candidates from outside Gauteng province will be assisted with travel and accommodation costs by the Production Company.
- All record dates are subject to change; however, the production house will endeavor to adhere to the schedule as far as possible.
- Entrants cannot have any other responsibilities or commitments (such as work or family etc.) during the agreed date and time.
- All entrants must be 18 years or older and in possession of a valid *South African ID document*.
- Candidates enter in their individual capacity and may not provide a proxy to play/record on their behalf.
- On the day of the recording, candidates must agree to all and any *Covid-19 Protocols* as set out by the Production Company and in line with Government gazette regulations and protocols.
- All entrants must agree to the “Access the Cash” Game Show Competition rules as set out by the Production Company; these will be explained to contestants on the day of the recording.
- During the Production and Broadcast of “Access The Cash”, the *Social Media* behaviour and activity of all participants will be monitored and all activity must adhere to the Cash Converters and e.tv social media guidelines and protocols as set out in the Red Pepper “performers agreement” which will be shared prior to recording.
- Selection of all participants will be at the discretion of Cash Converters in association with Red Pepper Pictures. All decisions will be final.
- Red PepperPictures, Cash Converters, and e.tv reserves their right to cancel the production or participation of any individual on short notice.
- In the event that the production is cancelled, Cash Converters will not be held liable for costs incurred or be responsible for any expectations not met with regards to the production.
- All prize money and prizes owed to the contestants will be paid out one (1) week after the TV broadcast of the episode in which the contestant appears.

- Payment will be made into a South African bank account by way of an EFT transaction from Cash Converters Southern Africa.
- By entering “Access the Cash” participants agree to be filmed for the TV production and to the broadcast of the material on all the e.tv and Cash Converters platforms including on social media platforms for an as yet undetermined period of time.
- By entering “Access the Cash”, participants acknowledge all the terms and conditions and agree that Cash Converters will not be held liable for any loss or damages that may occur during the course of the production.
- The competition is open to existing and new customers but excludes the following people:
 - 2.1. Directors, members, partners, agents, employees or consultants of Cash Converters South Africa;
 - 2.2. People who are not legal residents and/or legal citizens of the Republic of South Africa;
 - 2.3. Spouse, life partner, parent, child, brother, sister, business partner, supplier, or any marketing service providers in respect of the competition, or any other person who directly or indirectly controls or is controlled by the promoter or suppliers of goods or services in connection with this competition or associates of any of the persons specified in 2.1 above; and
 - 2.4. Persons under the age of 18 years.
